Today, the firm is working to make the Prime Minister's plan to create homes for homeless individuals and families by 2025 a reality. The corporation is always looking for fresh business ideas and alliances, especially with businesses from the United States, Europe, and Asia that may introduce new technology and insights.

The Group also owns shares of many enterprises such as National Bank Limited, Pragati Insurance Limited, and Pragati Life Insurance Limited.
